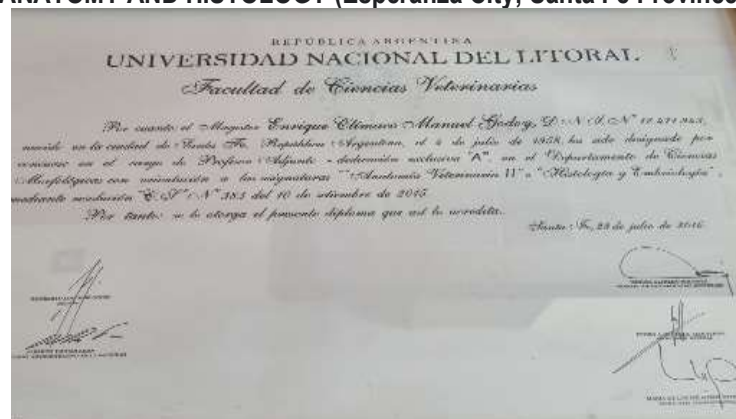

3. Training History (From enrollment to present)

Personal Profile

I started practicing Taekwon Do in 1971 in Santa Fe province, with teacher Sung Su Kin, being the first practitioner on this martial art in Santa Fe.

I took part in the first National Taekwon Do ITF championship in 1974. It was held in Obras Sanitarias Stadium in Buenos Aires where I got the second place in single fight.

Then, I took part in the National championship in 1975, in the capital city of Santa Fe where I got the second place in Matsoki and the first place in the break skill technique.

I became first dan black belt in 1976. At the same time, I began my university studies in the Veterinary Sciences College in Esperanza city.

I opened the first Taekwon Do school in Esperanza in 1980. Esperanza is located about 40 kms from Santa Fe. Then, I started teaching in the Police High School in Santa Fe, and in General Belgrano Military Lyceum in Recreo, a town near Santa Fe.

I got my degree as a second dan in 1982, in Rosario, Santa Fe.

I introduced Taekwon Do in Rafaela in 1985. Rafaela is an important city which is located about 90 kms from Santa Fe capital.

In order to make Taekwon Do known I opened new schools, not only in Santa Fe province, but in other provinces such as Cordoba and Entre Rios, as well.

Kwan Duk Chung became my teacher in 1986.

In the same year, I organized the first Taekwon Do championship in Rafaela.

After that, I took part in the Seminar given by Master Park Chung Tae in the ICA (Argentinian Chung Institute) in 1987.

I became third dan with Grand Master Choi Hon Hi in the Argentinian Chung Institute in 1987.

From 1987 to 1995, I was the general secretary in FAAT (Argentinian Federation of Taekwon Do associations)

I got the degree as fourth dan with Master Yun Hon Sun in 1990, in Buenos Aires where I was under the leadership of Senior Grand Master Adolfo Villanueva. The examiners were Master Kwan Duck Chung and Yu Hon Sun.

Then, I organized the first Argentinian championship FAAT in Santa Fe city in 1990.

I travelled to the USA with SGM Adolfo Villanueva in 1991 in order to train with Master Kwan Duck Chung.

I was distinguished as a sportsman by the government of Esperanza city in 1992.

Next, I travelled to the USA again in 1993, to train with Master Kwan Duck Chung.

I ratified my degree as a fourth dan with ITF certificate in 1994.

I got my degree as a sixth dan in 1996. The examiners were Grand Master Choi Hon Hi, Master Choi Jung Wa and SGM Adolfo Villanueva. Then, I went to the International Seminar given by Master Choi Hon Hi in Tucuman, Argentina.

I organized the international Seminar given by Choi Jung Wa in 1998, in Santa Fe city.

My love and devotion for Taekwon Do took me not only to spread it, but to teach it for free in different neighborhoods in Esperanza, as well. Therefore, I introduced a project called “Por un niño menos en la calle” (A child on the streets never again) . It was created in order to teach poor children for free, and keep them away from drugs and for being long hours on the streets. The project was supported by the local government and socially recognized. That project was used by other instructors of the organization.

I got my degree as a seventh dan in 2003.

I was a member of the Committee which organized the Panamerican in 2004 in Mar del Plata. Grand Master Chan Hung attended the congress.

Next year, in 2005, I organized the National FAAT championship held in Esperanza.

I was a member of the Committee which organized the Panamerican in Tarija, Bolivia and took part in the congress held that year.

The following year, in 2009, I was the Chairman and Judge in the World championship held in Saint Petersburg, taking an Argentinian competitor with me.

I was the representative of Argentina and voted to choose the President of ITF, and Grand Master Chan Hung was reelected.

I sent competitors to the World championship in Belarus in 2010.

The following year, in 2011, I sent competitors to the World championship in Korea.

In order to raise funds and toys for children with cancer and other terminal diseases, I organized a regional championship in 2012. The collected money and toys were given to different hospitals of Santa Fe on Kings day.

I got my degree as eighth dan in 2014; I travelled to Tajikistan together with members of FAAT and its President SGM Adolfo Villanueva.

I was a judge in the World Open championship in Belarus in 2017 and President in 2018.

I have been a member of the FAAT Board of directors, whose President is SGM Adolfo Villanueva, from 1987 to present.

Nowadays, I am the secretary of FAAT, and my task is to help and support SGM Adolfo Villanueva for the growth of ITF.
